#### 3 DECLARATIONS OF INTEREST RELATING TO ITEMS ON THE AGENDA

#### 4 PUBLIC SPEAKING TIME

Adrienne Waghorn raised questions about the location of the asphalt plant and the CVSC, and the timeframes around these projects.

Ms Natasha Tod advised that the asphalt plant will be for two years or until they no longer need it. If Transmisison Gully was not finished, they would have to apply for an extension. The Council are waiting for NZTA approval as the landowner before they can complete the consent. Staff need all the information before they can decide if it needs to be notified or not. The consent needs to meet certain triggers before public notification is required. Assessment of the environmental effects of the asphalt plant is required before the decision is made.

**Rhonda Mauat** asked if we know how many truck movements there are per day at the moment. She also expressed concerns about the wetlands and leaching from the asphalt plant.

Ms Natasha Tod advised that the asphalt plant is a mobile plant and is self contained and not discharge to the ground. It has been used elsewhere around the district previously. She also advised that TG have considered several sites for this plant and taken account of factors such as truck movements in choosing the current proposed site.

Ms Holly Ewens advised that the asphalt plant consent application is uploaded at Paekakariki.nz under Official Stuff for the public to view. Clause 5.4.1 of the application is about noise.

Ms Tina Pope gave an overview of the process for consenting to attendees. It was raised that staff also decide on any conditions required in the consent. If it's notified, people can have their say on it. There is not much opportunity for public to have their say if non-notified.

There was a question posed from attendees about whether there is any way the community could have input.

#### 1 DECEMBER 2020

Ms Natasha Tod suggested they could write a letter to the resource consents team but emphasised it had no legal weight for a non-notified consent. She also advised that the Council has a compliance team who will be monitoring the activity to ensure the consent is being complied with and also able to respond to complaints.

Ms Holly Ewens said that Darren Utting from TG has been very forthcoming with information to the Community Board.

**Ms Jan Nisbett** expressed concern around Ocean Road beach access – what is happening with the steps? She also wanted to know what is the process of checking for overgrown vegetation on the streets in Paekākāriki, especially Ocean Road intersection, and concerns around coverings and clips for rubbish bins. She raised the issues of the lack of a cycle sign on rise in Wellington Road and cycle sharrows on Wellington Road. She expressed concern about communication from NZTA about the CVSC open day. She asked the Board to insist on large signage at Ames St and Raumati straights to make it safer for cyclists.

Ms Tina Pope encouraged members of the public to put in service requests for overgrown vegetation, using the Antenno app or calling the call centre.

Ms Natasha Tod will follow up on the cycle sign and Ocean Road beach access.

#### 7.1 QUEEN ELIZABETH PARK UPDATE

Wayne Boness from Greater Wellington Regional Council gave the following updates:

- Experts will be onsite for asphalt plant stakeholder discussion this Thursday
- Public consultation for Parks Network plan 2020-2030 undertaken 400 submissions received, hearings and analysis have been completed on this. This will govern the look and feel of the park and needs to be approved by Greater Wellington Regional Council before implementation.
- Current grazing licence finished at the end of October 2020 and 128.5 hectares retired. 210 hectares available for 3 years grazing.
- Have done analysis on soil for peat testing
- Planning in fire buffers for the future working with Fire Emergency New Zealand on this and to develop a tactical response plan for emergencies
- McLean Trust planting project
- Coastal track realignment more lwi consultation needed before this proceeds
- Roundabout at the Mackays entrance to support traffic flow

#### 1 DECEMBER 2020

- More parking by Ramaroa building incuding horse float parking and bike racks
- Coastal retreat project reshaping dunes, Wainui stream will still be able to do its natural passage
- Requested the Board support for relocation Budge house ranger station and their presence in the park – would like a letter from the Board for this support
- New picnic areas and toilets
- The Coastal retreat project will take 3-4 years to roll out using a phased approach, and will have some dependency on the surf club rebuild
- Surf lifesaving club rebuild needs Greater Wellington Regional Council approval and then public consultation will be undertaken early next year. There will be multi use spaces within the building for community use.

The Chair requested a minute's silence in respect of the previous Chair Phil Edwards who passed away recently.

#### 4 PUBLIC SPEAKING TIME

**Sue Douglas** from Kapiti Coast Roller Derby Team spoke to their funding application. The team trains every Sunday at Kapiti College gym. Due to the high costs of the rental of gym, the funding would be used to keep practice accessible for as many people as possible. A lot of the team are Paekākāriki based. All levels of ability are welcome to come along and have a go. The team are also applying for funding from other community boards as well.

Jenny Clark spoke to her application for Pearl and Florrie's way mural funding. Artist Phill Simmonds has done some concept art work for the mural. The project has received funds from Wellington Community Trust for approximately half of the costs. Permission has been sought from KCDC to do this work. Mr James Jefferson said he would assist with getting an answer from KCDC about permissions. Relatives of Pearl and Florrie have supported this mural as well. Funding would go towards materials for the mural. Creative Community Funding applications close this Sunday so need to be in on Friday, Jenny will apply for this as well.

**Graham Coe and Dave Johnson** spoke about their Paekākāriki Library submission. When the library was originally set up, it was going to be named the Jean Andrews Memorial Library. They would like it renamed as previously agreed with Council. The submission also requests an upgrade of the entrance way owned by Council so it reflects the lwi Ngati Haumia, possibly including a gateway.

#### 23 FEBRUARY 2021

They also raised concerns with staffing of library, which is currently 10 hours per week. They would like a 40 hour a week librarian so more of the community could use the library, including the school. It could also become an information centre for the Council as well.

Mr James Jefferson suggested the library manager could pick up the renaming of the library with the Council's lwi Partnerships team to progress. He advises that items 2 and 3 are levels of service discussions. He recommended that they should submit a proposal for this in the Long Term Plan for small capital and increased levels of service.

The Board unanimously supported this proposal.

Ms Tina Pope noted that the renaming and upgrade of entrance way may align with an existing Long Term Plan bid to make Ngati Haumia more visible in Paekākāriki.

There was a question from a member of the public about whether there was any data about demand for the library services in Paekākāriki.

Three reports were tabled at the meeting:

- Proposed Weigh Right Mackays Crossing CVC Summary of Public Consultation 14 October – 18 November 2020
- Waka Kotahi Stakeholder Workshop Recreational User Group Suggestions for Mackays Crossing – Thursday 3 December 2020
- National Weigh Right Programme Addendum to the Road Safety Audit of Details Signs: SH1, Mackays Crossing.

The new Commercial Vehicle Safety Centre (CVSC) is proposed for the site near Mackays Crossing as once Transmission Gully opens, the Vehicle Safety Centre at Plimmerton will no longer be relevant.

Consultation on the proposed site was undertake this late last year and Waka Kotahi has produced a report from the consultation.

Themes identified from the report were:

- Access to and from the proposed CVSC
- Location of CVSC itself
- Interactions between heavy vehicles and other users
- Number of vehicles expected to use the CVSC
- Upgrade existing paths and facilities around QE2 Park near the CVSC
- Manage varying demands of park users and CVSC users

A multi-criteria analysis of the location is online already to show how the decision was reached.

On another CVSC there are roughly 15 vehicles using it an hour. During peak periods the road will regularly have around 300 vehicles per hour.

Work going on by Transmission Gully to improve shared path at the moment. The CVSC is considering further work to be done, including signage for existing shared pathway from the north of Paekākāriki around to Queen Elizabeth II Park.

Waka Kotahi are having ongoing discussions with Police and Greater Wellington Regional Council how best to make competing demands of park users and CVSC.

A further workshop was held with user group representatives including cyclists and horse riders.

Graham Taylor - safety audit

Transmission Gully will finish its work then Waka Kotahi will tidy up and finish work afterwards.

After discussion with the user group, Waka Kotahi agreed to put in post and rail fence suitable for horses and cyclists.

Many submissions received about the underpass and interactions with other users. The trucks will use Paekākāriki Interchange instead of Mackays Interchange. Only one direction of trucks will use the underpass. This will equate to approximately 5 trucks per hour on average. This will largely remove the conflict between park users and CVSC users.

The traffic load does not justify the placing of a round bout at Paekākāriki intersection.

Concern raised that no acceleration lane recommended on existing road. Waka Kotahi advised that this was not necessary due to love level of traffic on the road.

Concern raised about north bound trucks leaving the CVSC. Signage will be provided as they exit and all trucks will be directed to Paekākāriki Interchange.

Cr Janet Holborow raised a question about cycle access along local access road. The road currently has 2m wide cycle shoulders. SH1 Revocation project will address this later. A safety audit will be undertaken and traffic volumes assessed. Cycle access to the eastern corridor is important and Waka Kotahi will be looking at this as part of the Revocation project.

#### 23 FEBRUARY 2021

Before Transmission Gully opens, a Waka Kotahi Stage 4 safety audit will be undertaken and include monitoring of traffic flows. The is currently 450m of visibility from where the trucks are to the Paekākāriki Interchange. An independent safety audit has been undertaken and Waka Kotahi have addressed the points raised. The report includes a decision tracking form to show mitigation of issues that were raised.

The Chair thanked Waka Kotahi for attending and listening to the community's concerns.
