# 7.1 CREATIVE COMMUNITIES SCHEME\_CONSIDERATON OF APPLICATIONS FOR FUNDING ROUND 2, 2019-20

#### **PURPOSE OF REPORT**

This report presents applications for Creative Communities Scheme funding for consideration by the Creative Communities Assessment Committee (sub-committee of the Grants Allocation Committee).

#### **DELEGATION**

The Grants Allocation Committee may make a decision under Section B.6 of the Governance Structure and Delegations:

The Committee will consider and allocate grant moneys in accordance with the meeting cycles and criteria of five granting programmes, including money granted by Creative New Zealand.

# **BACKGROUND**

# **Administration of the Creative Communities Scheme**

- The Kāpiti Coast District Council (the Council) administers the Creative Communities Scheme under contract with Creative New Zealand. The funds are allocated nationally by Creative New Zealand on a population basis and distributed locally in accordance with their guidelines.
- The Scheme was established to provide support to arts and cultural activities taking place within a local area. For the purposes of the Scheme, art is defined as "all forms of creative and interpretative expression".
- There are two funding allocation rounds per year. This report pertains to the **second** funding round for the financial year 2019/20. Applications for the current round closed on Friday 21 February 2020. Each application is checked by staff for eligibility and then individually assessed by Committee members prior to this meeting.
- The 2019/20 allocation from Creative New Zealand for Kāpiti Coast District Council is \$46,920. If this is not fully spent in this financial year, only 15% may be retained for the next financial year, and the balance returned. The Council has to apply for Creative New Zealand approval to cancel an allocation round and to roll over any funding to the next year.
- Council budgeted \$48,157 for 2019/20 for grant funding. Advertising and promotion costs for the full year were \$2185.55 (around 5% of the Creative New Zealand allocation), leaving a net figure of \$45,971.45 available for grants over the full year. The committee allocated \$22,904.40 in the first funding round.
- 7 The total available for grant funding in this round is **\$23,067.05**. This is a little more than last time because promotion costs were slightly lower than budgeted.
- We received 23 applications but three were subsequently withdrawn because of ineligibility, or the applicant decided to seek funding elsewhere. Three more were withdrawn because of the impact of COVID-19 pandemic response on planning. The **sixteen** applications submitted for the Committee's consideration request a total of **\$31,282.22** of funding grants as contributions towards the applicants' projects. The total of the requests exceeds the amount available by **\$8,215.17**.

## **Purpose of the Scheme**

- 9 The purpose of the Scheme, as set out by Creative New Zealand, is to stimulate and provide support to arts and cultural activities that increase participation and increase the range and diversity of projects that make the arts more attractive and relevant to the various local communities.
- 10 Creative New Zealand notes that a community is defined by the people within it, and can include religious, cultural, or other self-defined communities. The purpose of the Creative Communities Scheme is to support "grassroots" activities.
- 11 Creative New Zealand requires Councils to have representation from Māori on the Assessment committee, and seeks feedback in its regular surveys about how the council encourages application with a Toi Māori focus. For the last three rounds, we have specifically encouraged applications for projects with a focus on Ngā Toi Māori.

# **Eligibility**

- 12 Creative New Zealand stipulates that projects considered under this Scheme should:
  - take place within the Kāpiti Coast District; and/or
  - produce benefits which are largely experienced within the Kāpiti Coast District.

#### **Priorities**

- Projects seeking assistance must meet at least one of three funding criteria set by Creative New Zealand. These are:
  - Access and Participation: creating opportunities for local communities to engage with and participate in local arts activities;
  - Diversity: supporting diverse arts and cultural traditions of our local communities, to enrich cultural diversity; and
  - **Young people:** enabling and encouraging young people under 18 years to engage with and actively participate in the arts.

# **Applications**

- 14 A schedule of the applications for funding is attached as **Appendix A** to this report.
- 15 Each successful applicant is required to return a project accountability report and to participate in any funding audit of their organisation or project conducted by the Kāpiti Coast District Council. Staff track the receipt of the project accountability reports, and will report highlights of completed projects to the Grants Allocation Committee at the meeting.

#### **ISSUES AND OPTIONS**

# Issues

# Impact of COVID-19 pandemic:

- The funding allocation meeting due on 9 April 2020 was cancelled because of the Government lockdown in response to the pandemic. All applicants were notified and asked at that point about their plans for their project, and again once the rescheduled meeting date (11 June 2020) was confirmed.
- 17 Creative New Zealand advises that for "projects that are not affected by current public health guidelines, and that are still going ahead, applicants should develop a Covid-19 risk management plan and follow all public health guidance on <a href="www.covid-19.govt.nz">www.covid-19.govt.nz</a> ". We have advised all applicants of this requirement and asked them to provide assurance they have in place a health and safety management plan, and contingency planning for any change in Alert Levels.

- 18 Each application presented to members in the application packs sent to members will have a cover sheet, showing updated dates of the project and other updated information such as venue changes, limitation of numbers, or changes to revenue from attendance fees or ticket sales.
- 19 Many applicants have rescheduled their projects to later this calendar year or in the first part of 2021. Three applicants withdrew their applications as the situation is still unclear or the lockdown and COVID-19 Alert Level restrictions have severely limited on planning and preparation time.
- 20 Creative New Zealand recommends extra time at the meeting to allow discussion on the new project dates and applicants' contingency plans.
- Creative NZ also advised that "if the updated project timeline would place the project outside of the 12 month period of the grant, (the administrator) can advise the applicant that it will not be assessed in the current round, but it will be assessed in the next funding round, and that the applicant can choose to update the application at the next round if they wish (or it can proceed to assessment as is)." (This case applies to potentially three applications listed in Appendix A under "Withdrawn because of COVID-19")
- One applicant, Kāpiti Concert Orchestra, has applied to Creative New Zealand's Arts Continuity Grant. If they are successful (meaning they become ineligible for Creative Community Scheme funding), or if they still do not know the result of their application, they will withdraw their application. In either case, the Committee will be advised at the meeting.
- The Council may decide that for safety, the allocation meeting will not include all of the public presentation part. Applicants have been advised of this, and if the Committee particularly wishes to hear from an applicant, that person will be invited to present in person or by virtual means.

#### Discretion:

- A Creative Communities assessment committee has discretion in certain "grey areas', or in relation to particular priorities decided by that committee. Creative New Zealand advises committees to always consider "Does this project benefit the arts?"
- All applications are checked by staff for eligibility and those submitted can be considered eligible according to the Guidelines and advice received from Creative New Zealand.
- For some applications submitted in the current round, the committee needs to decide whether the outcome of the project is primarily to benefit the arts, or another outcome such as social or mental well-being.
- Also, the committee has discretion whether to accept an application for funding an aspect or stage of a large programme or project, as a separate project. The committee has accepted some applications of this kind in the past, so applicants seeking funding in this way have been advised to apply but that the committee has discretion in this matter.
- The committee also has discretion to grant extensions to projects. A grant recipient in the March 2019, Shona Jaunas, notified staff that her project, production of a community musical "Small Town", was delayed from late October/November 2019. The script development stage was completed in March 2020 but Shona requests an extension to enable the next stage of the project to be completed later in 2020.

# **CONSIDERATIONS**

# **Policy considerations**

Council policy has been to budget a small amount to support the substantive Creative New Zealand allocation for grant funding.

# Legal considerations

30 There are no legal considerations.

#### **Financial considerations**

- The 2019/20 Council budget for the Creative Communities grant funding is **\$48,157.00**, including the Creative New Zealand allocation and the Council contribution. The total available for grant funding in this round is **\$23,067.05**.
- 32 The <u>CCS Assessors Guide 2018.pdf</u> provides information and guidance about taking a strategic approach to making funding decisions that represent the best use of the funds available and deliver strongly to the funding criteria from Creative New Zealand.
- Please note that we have been advised by Creative New Zealand that funds requested for providing food are now eligible for inclusion in the grant. This recognises the importance of manaakitanga as essential to enable the outcomes of many arts projects.

# Tāngata whenua considerations

- 34 Creative New Zealand requires that at least one representative from local iwi sits on the assessment panel or committee. This Committee includes up to three iwi representatives nominated by Te Whakaminenga o Kāpiti.
- 35 This Committee also includes a Youth Representative

# Strategic considerations

- In supporting the arts in Kāpiti, the Creative Community Scheme grants allocation aligns with the Council's strategic vision toitū Kāpiti and its ten-year outcome, *A positive response to our distinct district identity,* and also to the kaupapa expressed in the "Vision from Tāngata Whenua".
- 37 Support of arts projects also contributes to the Council's long-term objectives of:
- "An attractive and distinctive Kāpiti identity and sense of place that make people proud to live, work, and play here"; and
- "A resilient community that has support for basic needs and feels safe and connected".
- 38 Supporting the arts also is an important way councils fulfil their purpose in promoting the social and cultural wellbeing of the community, as described in the changes in 2019 to the Local Government Act 2002 (section 10). Many applications note the social benefit of the project gained through community involvement in arts activities.
- The recommendations in this report have a low level of significance under the Council's Significance and Engagement Policy.

# SIGNIFICANCE AND ENGAGEMENT

# Significance policy

The recommendations in this report have a low level of significance under the Council's Significance and Engagement Policy.

#### **Engagement planning**

41 An engagement plan is not needed to implement this decision.

#### **Publicity**

- For this round, we increased the range of our promotion and received twice as many of applications as the previous round.
- 43 Communications from the Council included:

- publicising the Scheme at the time of seeking applications, and describing some projects that received funding from the last funding round;
- repeated posts on social media including to specific artists' groups;
- advertising in local newspapers and on radio;
- displays in the district libraries, with printed application forms and guidance material; and
- a media release and information on the Council's own communications channels to publicise the funding decisions and the projects supported by these grants soon after the Grants Allocation Committee meeting.
- 44 Promotional material for this round again included wording to specifically encourage applicants with a Toi Māori focus. In this round we received four applications for projects with a Toi Māori focus, although two of these have been withdrawn.

#### Other considerations
