7.1 CREATIVE COMMUNITIES SCHEME - CONSIDERATION OF APPLICATIONS FOR FUNDING ROUND

PURPOSE OF REPORT

This report presents applications for Creative Communities Scheme funding for consideration by the Creative Communities Assessment Committee (sub-committee of the Grants Allocation Committee).

DELEGATION

The Grants Allocation Committee may make a decision to approve grant moneys under Section B.6 of the Governance Structure and Delegations:

The Committee will consider and allocate grant moneys in accordance with the meeting cycles and criteria of five granting programmes, including money granted by Creative New Zealand.

BACKGROUND

Administration of the Creative Communities Scheme

- The Kāpiti Coast District Council (the Council) administers the Creative Communities Scheme under contract with Creative New Zealand. The funds are allocated nationally by Creative New Zealand on a population basis and distributed locally in accordance with their quidelines.
- The Scheme was established to provide support to arts and cultural activities taking place within a local area. For the purposes of the Scheme, art is defined as "all forms of creative and interpretative expression".
- There are two funding allocation rounds per year, usually in September and March. This report pertains to the **first** funding round for the financial year 2021/22. Applications for the current round closed on Sunday 1 August 2021. Staff check each application for eligibility and then Committee members assess them individually prior to this meeting, using the scoring sheet (attached separately to the email accompanying this report).
- 6 Table 1 shows the grant allocations and costs for 2021/22.

- 7 Creative New Zealand allocated \$47,203.80 for Kāpiti Coast District Council for the 2021/22 financial year. In total, Council budgeted \$51,810.00 in 2021/22 for grant funding. Creative New Zealand allows for up to 7% of its allocation to be used for advertising and promotion. For this financial year, \$3,304.27 was allocated for promotion costs. (Actual advertising costs for this round were less than half of the allocated figure.)
- The net figure available for grants over the full year comes to **\$48,505.73**, which is split evenly across the two funding rounds.
- 9 The total available for grant funding in the September 2021 round is **\$24,729.07**.
- We received **18** applications to submit to the Committee for consideration. 17 applications are attached as individual appendices to this report, as one applicant has withdrawn because of the impact of COVID-19. The total requested is **\$39,813.20** which exceeds the funds available for this funding round by **\$15,084.13**.

Purpose of the Scheme

- The purpose of the Scheme, as set out by Creative New Zealand, is to stimulate and provide support to arts and cultural activities that increase participation and increase the range and diversity of projects that make the arts more attractive and relevant to the various local communities.
- 12 Creative New Zealand notes that a community is defined by the people within it, and can include religious, cultural, or other self-defined communities. The purpose of the Creative Communities Scheme is to support "grassroots" activities.
- 13 Creative New Zealand requires Councils to have representation from Māori on the Assessment committee and seeks feedback in its regular surveys about how the council encourages application with a Toi Māori focus. For the last few funding rounds, we have specifically encouraged applications for projects with a focus on Ngā Toi Māori

Eligibility

- 14 Creative New Zealand stipulates that projects considered under this Scheme should:
 - take place within the Kāpiti Coast District; and/or
 - produce benefits that are largely experienced within the Kāpiti Coast District.

Priorities

- Projects seeking assistance must meet at least one of three funding criteria set by Creative New Zealand. These are:
 - Access and Participation: creating opportunities for local communities to engage with and participate in local arts activities;
 - Diversity: supporting diverse arts and cultural traditions of our local communities, to enrich cultural diversity; and
 - Young people: enabling and encouraging young people under 18 years to engage with and actively participate in the arts.
- In addition to these three criteria, local authorities can set their own local strategic priorities. At the allocation meeting in October 2020, the Committee resolved:
 - That the committee will continue its focus on projects that assist recovery from the lockdown, and resilience to the impact of the COVID19 pandemic for the next funding round. (GACC_20201022_MIN_2292, Resolution 51)
- 17 Given the ongoing impacts of COVID-19 on the community, we have continued to reflect this priority and the continued focus on Ngā Toi Māori in our advertising.

A recommendation has also been included to continue the focus on projects that assist recovery and resilience given the ongoing nature of COVID-19.

Applications

- The schedule of applications for funding (Appendix 1), a summary of the applications (Appendix 2) and further supporting information (Appendix 3) are attached to this report. The applications are available under separate cover through the LG Hub and will be provided in hard copy to those members who wish this.
- 20 Successful applicants are required to return a project accountability report and to participate in any funding audit of their organisation or project conducted by the Kāpiti Coast District Council. Staff track the receipt of the project accountability reports and will report highlights of completed projects to the Grants Allocation Committee at the meeting.

ISSUES AND OPTIONS

Issues

Impact of COVID-19 pandemic:

- 21 Creative New Zealand advised in 2020 that applicants should develop a COVID-19 risk management plan and follow all public health guidance on www.covid-19.govt.nz. We continue to advise all applicants of this requirement and to seek assurance that they have in place a health and safety management plan, and contingency planning for any change in Alert Levels.
- 22 Most applicants indicated contingency arrangements if they are not able to carry out their projects on the dates they have set, because of changing COVID-19 alert levels or conditions under any level.
- 23 Following the Government's recent changes to the conditions for proceeding with events at Level 2, known as "Delta Level 2", we are in the process of contacting all applicants to ensure they are aware of these changes and are updating their health and safety management plans for resubmission. At the time of submitting this report, we have received only one withdrawal (number 7 in the supporting material). We will update committee members about any further withdrawals or changes when we have contacted all the applicants.

Extensions:

- The Committee does have discretion to allow extensions for grant recipients who have not been able to complete their projects or hold their event during the timeframe due to COVID-19 alert level restrictions. The Committee can also allow extensions for other reasons that the Committee accepts.
- Council has received a request from Sonia Hardie at Te Raukura Ki Kāpiti for an extension of time to complete the project "Professional editing mentoring for rangatahi film makers, for promotional material creation for Te Raukura ki Kāpiti". The Committee granted Sonia \$1500 towards this project in October 2020. The project was delayed firstly by the original educator becoming unavailable through sickness, and subsequently by limited venue staffing capacity and disruption from the recent lockdown. Sonia has requested an extension of six months, to enable rescheduling the project after senior exams as a summer activity, or early in the new school year. We have made a recommendation for the committee to decide on this (numbered paragraph 43 in this report).

Discretion:

A Creative Communities assessment committee has discretion in certain "grey areas", or in relation to particular priorities decided by that committee. Creative New Zealand advises committees to always consider "Does this project benefit the arts?"

- 27 All applications are checked by staff for eligibility and those submitted can be considered eligible according to the Guidelines and advice received from Creative New Zealand. For the applications involving school students, Creative New Zealand has advised that they satisfy the criteria as being outside of curriculum delivery.
- We sometimes receive an application for funding an aspect or stage of a large programme or project as a separate project, Creative New Zealand advises that such applications meet eligibility criteria, including projects that have received Creative New Zealand funding for an earlier stage of the project.
- Often, applications comment on the social wellbeing outcome of an arts activity. The committee has discretion to consider whether the outcome of the project is primarily to benefit the arts, or another outcome.

CONSIDERATIONS

Policy considerations

30 There are no Policy considerations.

Legal considerations

31 There are no legal considerations.

Financial considerations

The <u>CCS Assessors Guide 2019-22 Updated July 2020.pdf</u> provides information and guidance about taking a strategic approach to making funding decisions that represent the best use of the funds available and deliver strongly to the funding criteria from Creative New Zealand.

Tāngata whenua considerations

Creative New Zealand requires that at least one representative from local iwi sits on the assessment panel or committee. This Committee includes up to three iwi representatives nominated by Te Whakaminenga o Kāpiti. The decision for nomination for that representative currently is sitting with Te Whakaminenga. If no representative is nominated before the meeting, the committee should ensure they consider applications from a te ao Māori perspective as part of their decision-making.

Committee membership

The resignation of a Committee member earlier in 2021 resulted in a vacancy for this committee. Subsequent to advertising and directly approaching potential interested parties, three applications were received and submitted to Council. Council appointed Michelle Scullion as a community representative at the Council meeting on 26 August 2021.

Strategic considerations

- In supporting the arts in Kāpiti, the Creative Community Scheme grants allocation aligns with the Council's strategic vision *toitū Kāpiti* and the outcome, *Our communities are resilient, safe, healthy and connected. Everyone has a sense of belonging and can access the resources and services they need.* Grants funding contributes to this objective through:
 - facilitating connectivity across the community (groups and individuals) and between communities
 - funding locally-led initiatives.¹

- 36 Supporting the arts also is an important way councils fulfil their purpose in promoting the social and cultural wellbeing of the community, as described in the changes in 2019 to the Local Government Act 2002 (section 10).² Many applications note the social benefit of the project gained through community involvement in arts activities.
- 37 The committee, in taking a more strategic approach to allocating funds and articulating local priorities for this and the previous round is in alignment with the Council's continued focus on community recovery. The Council recognises that supporting the arts contributes to the long-term recovery effort from the pandemic.

SIGNIFICANCE AND ENGAGEMENT

Significance policy

The recommendations in this report have a low level of significance under the Council's Significance and Engagement Policy.

Engagement planning

39 An engagement plan is not needed to implement this decision.

Publicity

- We undertook a broad promotional campaign to advertise the Scheme and the applications for this funding round, through a variety of channels.
- We advertised we would provide workshops to assist people considering applying, but received no interest for this. However, please note the good awareness of the fund due to the current oversubscription to the fund this funding round.
