TE PŪTAKE | PURPOSE

- 1 The purpose of this paper is to provide an update on progress with the Health Strategy.

TAUNAKITANGA | RECOMMENDATIONS

- A. **Note** the update provided in this report.

TŪĀPAPA | BACKGROUND

- 2 The Social Sustainability Subcommittee last received an update on the Health Strategy in November 2023, agreeing with the content of the Direction of Travel content for consultation with the community.
- 3 On 22 February 2024, the Strategy, Operations and Finance Committee approved the Direction of Travel document for consultation with the community. Consultation was undertaken from 18 March to 20 April 2024.
- 4 We received responses from 75 individuals and are processing these, along with feedback received on health in our Vision Kāpiti consultation, to inform the final strategy. More information on this will be provided to SSSC and SOF before the approval of the Final Strategy. However, there has been good support for the topics covered as representative of what the community cares about.
- 5 We are now looking to bring together more key sector stakeholders for discussion on how we can collectively make progress towards what our community wants.
- 6 We will keep the SSSC up to date with arrangements for this.

HE TAKE | ISSUES

NGĀ KŌWHIRINGA | OPTIONS

NGĀ MAHI PANUKU | NEXT STEPS

- 9 We have scheduled specific discussions with:
 - 9.1 Iwi-Māori Partnership Board Chairs and Operational Leads.
 - 9.2 The Regional Lead for localities in Te Whatu Ora. This role covers the Te Whatu Ora Central Region, which includes the whole of Wellington up to Whanganui and Hawke's Bay, which means it covers the whole of our district.
- 10 Following this we are arranging to meet with locality leads for Te Whatu Ora, Capital, Coast and Hutt Valley and MidCentral districts, and Tu Ora Compass Health and Think Hauora, which are the overarching bodies representing primary care practices in our region (Primary Health Organisations).
- 11 After these initial discussions, we will seek to arrange a discussion with a broader range of stakeholders, with a potential workshop style.
- 12 We will keep the subcommittee up to date with arrangements.

TE PŪTAKE | PURPOSE

- 1 This report seeks the Social Sustainability Subcommittee's (SSSC's) endorsement of the Kāpiti Health Advisory Group's (KHAG) work plan for 2024/25 and provides an update on budget considerations.

HE WHAKARĀPOPOTO | EXECUTIVE SUMMARY

- 2 An executive summary is not required for this report.

TE TUKU HAEPAPA | DELEGATION

- 3 The Social Sustainability Subcommittee may consider this matter under section C.1. of the Governance Structure and delegations 2022-2025.

TAUNAKITANGA | RECOMMENDATIONS

That the Social Sustainability Subcommittee:

- A. **Recommends** that the Strategy, Operations and Finance Committee approves the work plan for the Kāpiti Health Advisory Group for 2024/25.
- B. **Notes** that budget considerations of up to \$5,000 will be funded within baseline funding from the Strategy & Growth Group.
- C. **Notes** that any changes to the Group's Terms of Reference that may be recommended as a result of the Council's review of advisory groups will be discussed with the Group and Chair of SSSC before being incorporated.

TŪĀPAPA | BACKGROUND

- 4 The Kāpiti Health Advisory Group (KHAG) has been in operation and supporting Council's work on identifying and advocating for health service improvements since 2017.
- 5 In 2023, Council agreed that KHAG be refreshed to enable free and frank, independent advice to Council. In September 2023, this Subcommittee recommended to the Strategy, Operations and Finance Committee that it approve the new terms of reference for KHAG. The Strategy Operations and Finance Committee agreed, and approved a 2023/24 work programme, establishing KHAG as an advisory group to Council, reporting through to the SSSC.

HE KŌRERORERO | DISCUSSION

- 6 KHAG has made good progress on a number of areas of its work programme. Recent updates to the SSSC have noted:
 - 6.1 That the Access to Services Working Group has been progressing work on a compelling case for a 'polyclinic' facility, focusing on an expansion of the Kāpiti Health centre.

- 6.2 The Transport Working Group has been engaging with Te Whatu Ora Capital, Coast and Hutt Valley on options for additional transport services, with the offer of support for a business case.
- 6.3 The Mental Health Working Group has been engaging with Statistics New Zealand on data to gain a picture of mental health in Kāpiti and have been meeting with Tu Ora Compass Primary Health Organisation and Kāpiti Youth Support.
- 6.4 The Public Health Working Group has recruited public health experts and have supported recommendations to SSSC and SOF on smoking legislation change and media opportunities to promote vaccination.
- 6.5 The Children and Young People Working Group has been in contact with key stakeholder organisations with a brief questionnaire on key issues to inform its work.
- 7 Further updates provided for May 2024 are noted in the attached 2024/25 work programme document.
- 8 It is proposed that the work programme for 2024/25 will continue with the existing focus areas, looking to make further progress on these.

He take | Issues

- 9 There are no proposed changes to the Terms of Reference for the Group. Ongoing work on a review of Council advisory groups may recommend some changes, such as including more information on Council codes of conduct. We will discuss any proposed changes with the Group and the SSSC before they are agreed.

Ngā kōwhiringa | Options

- 10 There are no options proposed for consideration.

Mana whenua

- 11 KHAG's Terms of Reference acknowledges that KHAG will seek to build a relationship with Kāpiti iwi and mana whenua, subject to iwi capacity and preference.
- 12 Should additional members be considered necessary to represent specific interests at a future date, the Terms of Reference will be updated by joint agreement between KHAG and the SSSC.

Panonitanga Āhuarangi me te Taiao | Climate change and Environment

- 13 This matter does not contain outcomes and actions specifically related to sustainability or climate change goals. However, there will be opportunities to support the Council's climate change and sustainability goals in the development of the Health Strategy.

Ahumoni me ngā rawa | Financial and resourcing

- 14 Approval of the 2023/24 work programme noted we would come back on budget considerations. KHAG has been able to progress its 2023/24 work with minor financial support from the S&G Group where necessary. However, KHAG would like to increase awareness activity in 24/25. Council officers have considered the proposed budget and this can be covered within baseline funding by the S&G Group.
- 15 This assumes:
 - 15.1 Council will continue to provide secretarial support to monthly meetings and will continue to host these in the Council Chambers.
 - 15.2 Any specific tasks undertaken at the request of Council will be funded by the Council to the extent agreed.

- 15.3 In the event that funds are needed for purposes that KCDC does not wish to fund, KHAG will attempt to fundraise through community sources.

Tūraru ā-Ture me te Whakahaere | Legal and Organisational Risk

- 16 There are no legal considerations for the purposes of this report.

Ngā pānga ki ngā kaupapa here | Policy impact

- 17 There is no direct policy impact from this paper. The work KHAG progresses will inform relevant policy development, including the Health Strategy.

- 19 From time to time, the group will update its stakeholders on the work it is doing. Significant updates to stakeholders will follow updates to the SSSC or its Chair.

- E. Notes the preliminary capital cost estimates and financial model for a three-court facility, including estimated operating subsidy, as detailed in the Indoor Courts Needs Analysis and Feasibility Report.
- F. Notes that Officers would need to undertake further investigation into potential timelines and pathways to identify funding for the development of a community indoor court facility.
- G. Agree that Officers should undertake a detailed investigation into the provision of a community indoor court facility, including understanding any benefits of including a 'Community Centre' within this facility.
- H. Notes that this work is being undertaken within existing operational Council budgets.
