8.1 RESERVE NAMING - LEON KIEL RESERVE

TE PŪTAKE | PURPOSE

This report discuses and makes a recommendation on the naming of a parcel of land at the intersection of Poplar Avenue and Renown Road in memory of the late Leon Kiel, a respected community member who made significant contributions to the Raumati community.

HE WHAKARĀPOPOTO | EXECUTIVE SUMMARY

- This report recommends that the Board consider naming the proposed reserve land at the intersection of Poplar Avenue and Renown Road, in memory of the late Leon Kiel. Mr. Kiel was a respected community member who made significant contributions to the Raumati community.
- The land is not currently held as a reserve under the Reserves Act 1977. It is proposed that a recommendation is made to Council in early 2025 to pass a resolution to declare and classify this land as a reserve under the Act. If the decision is made to declare and classify the land as a reserve, the name can be applied to the land as part of the classification process, if approved by this Board.

TE TUKU HAEPAPA | DELEGATION

The Raumati Community Board (Community Board) has the delegated authority to consider the naming of a reserve under 'Part D Community Boards' of the Governance Structure:

'Accepting or rejecting officer recommendations in respect of names for local roads (excluding the former State Highway) and any reserves, structures and commemorative places, in accordance with existing council policy'

TAUNAKITANGA | RECOMMENDATIONS

A. That the Raumati Community Board agrees in principle to name Section 110 Wainui District, under title WN27B/669, Leon Kiel Reserve, if Council passes a resolution to declare and classify the land as a reserve, in accordance with the Reserve Act 1977.

TŪĀPAPA | BACKGROUND

- On 22 August 2024, Raumati Community Board Chair, Bede Laracy, enquired with Council's Parks, Open Space and Environment Team regarding the land status of a parcel of land at the location of Raumati South's old post office, on the corner of Poplar Ave and Renown Rd, with a suggestion to name the land "Leon Kiel Reserve". A map of the land is provided in Appendix 3.
- Leon Kiel, a respected artist and community member, passed away on Friday, March 13, 2009, at the age of 50. He was instrumental in the creation of Whareroa Farm Reserve as a member of the Open Space Gateway group. Appendix 1 includes a list of Mr Kiel's community activities, provided by his family and members of the community. Appendix 2 contains a letter of support from former Kāpiti Coast District Council Mayor Jenny Rowan.
- 7 Council officers conducted a review of the land's status and determined the land was vested in the Kāpiti Borough Council, from the Crown, as Fee Simple land in 1985. For the land to be named as Leon Kiel Reserve, Council would need to pass a resolution to declare the land as a reserve and classify it for one of the purposes contained within the Act. As part of this process, a name in recognition of an individual, can be included in the gazette notice.

HE KÖRERORERO | DISCUSSION

He take | Issues

- 8 Before naming the land, Council must declare and classify it as a reserve in accordance with Section 14 of the Reserves Act 1977. If the land is declared a reserve and its purpose classified through a notice in the Gazette, the Council can simultaneously name the reserve.
- 9 Should Council decide not to pass a resolution to declare and classify the land as a Reserve, a decision can be made by the Board to name the land "Leon Kiel Park" in accordance with the Local Government Act 2022. In this case, the land would not be afforded the full protection of a reserve under the Reserves Act 1977.

Ngā kōwhiringa | Options

10 Do nothing - In accordance with Council's Reserves, Structures and Commemorative Places Naming Policy, an unnamed reserve, once declared a reserve, will take on the name of the street on which it is located.

'By default a reserve will inherit the name of the road it is on and a suffix related to its primary use, and will not have signage installed.'

Mana whenua

Initial discussions with Ātiawa ki Whakarongatai Charitable Trust staff have been undertaken with no initial concerns raised. The matter is to be discussed at the next Taiao Committee meeting and an update should be available when the Community Board meets on the 15th November.

Panonitanga Āhuarangi me te Taiao | Climate change and Environment

12 No relevant impact.

Ahumoni me ngā rawa | Financial and resourcing

Should the land be declared a reserve and be named after Leon Kiel, a new sign will be on crafted and installed on site. This would be at a cost of approximately \$1,200 and can be covered within existing budget.

Türaru ā-Ture me te Whakahaere | Legal and Organisational Risk

- Land can only be declared as a reserve and classified, by resolution of full Council. Should the land not be declared a reserve, it cannot be named as Leon Kiel Reserve. Declaring, classifying and naming the reserve must follow the process stipulated in the Reserves Act 1977.
- 15 If a resolution is not passed to declare the land as a reserve, the land could be named Leon Kiel Park.

Ngā pānga ki ngā kaupapa here | Policy impact

The Reserves, Structures and Commemorative Places naming policy 2011 provides a framework for commemorative places owned or managed by the Kāpiti Coast District Council. This policy states:

'An un-named reserve, new structure, newly acquired structure or a commemorative place can be named:

In recognition of an individual, family, hapū or iwi with strong historical links to the area or outstanding contributions to the District or New Zealand, and in those cases shall only have one name'

Hi Bede, sorry fr dragging the chain. How's this... Leon Kiel was a Raumati South identity. He was a stonemason, musician and environmental activist. He had a passion for his local community, was one of the community leaders who saved Whareroa Farm, was very involved with Friends of QE Park. His enormous influence on the area is still keenly felt 15 years after his death and he contributed hugely to Raumati South's reputation as a musical and creative hotspot. Soon after he died locals started referring to the small village park as Leon Kiel Park and musical events are held there on occasions.

Hi Bede,

I've consulted with a few people and made a list of community work Leon was involved in below. There will be others that I have forgotten but I think this covers the gist of it.

- Involved with the design of the Western Link Road concept that was vetoed by the transport minister of the time, Steven Joyce. However the focus on native plantings and non-vehicular pathways did heavily influence the final speedway design.
- A founding member of the original community group that saved Whareroa Farm from private subdivision.
- Helped KCDC set up the Cycleways and Bridleways group and he and landscape architect, Linda Kerkmeister mapped all the critical pathway links in the whole district so that the information could be filed on council computer and be protected for the community when developments were being planned.
- A founding member of the Raumati South Residents Association which was invited to be a partner with council in the design and plantings in Raumati South village, including the park. (The rock traffic islands and some of the plantings were implemented by council)
- Founding member of the Friends of Queen Elizabeth Park group formed to protect the park from a raceway being lobbied for by some councillors and car racing enthusiasts.
- Involved in the lobbying of council to protect the land that is now a community orchard in Raumati South from sale for private subdivision.
- Advocated for Te Rā school to be protected from the encroachment of the Kapiti Speedway.
- Involved in many other environmental projects in his role as a member of the Kapiti Environmental Action group and was particularly skilled in negotiating with developers to create community spaces and natural areas as part of new developments. For example: negotiating for wetlands, native plantings, and walking

tracks around the airport land development.

- Conceptualised the Kapiti Gateway Project that was formally recognised by KCDC and there is still ongoing work to bring it to fruition.
- As a musician he initiated many community events and was generally motivated by a
 desire to create a healthy community that was inclusive of everyone.
- As a landscaper he was the driver of a utility vehicle and had a saying 'UTE' which
 meant 'Under tree experience'. He believed that people needed this experience to be
 fully healthy.
- Was the recipient of a government Department of Conservation award for 'innovation in environmental protection'.

Quote from a community member:

"He was a well-loved member of the community, always prepared to lend a helping hand."

I hope this is what you need and thanks so much for your work on this.

Leon Keil was a mover and shaker, he was an amazing creative thinker, we became very close friends, in fact I considered him as a brother.

He was also a "doer", bringing his own thoughts and creative work into play, with every skill he had. His many stone walls and other sculptures around our district are still testament to him today. But it was his capacity to have the wider visions for our district that made him stand out from the rest of us.

He was a big strong man with very strong opinions, people loved him and we all worked with his ideas and energy to make this place more interesting to live in. He was very conscious of the environment, and very respective of the local mana whenua needs.

For me his major legacy, along with Rachels, would be the ongoing huge benefit that Whareroa Farm has given us, not only this district, but also the region. Their vision, when eventually actioned has allowed us all the opportunity to experience the recreational open space that is becoming more and more difficult to protect. This farm along side QEP, is a fantastic asset for us all and future generations.

Leon did maintenance work on the little village green, he helped clear the bamboo, and had a wee vision for its space. We talked about the village green being named after him at his tangi, so it is very timely now to action this and get it formalized.

This is a very worthy cause, Leon has all the attributes of a good decent human being, and to keep his energy in the village is totally appropriate in my view.

TŪĀPAPA | BACKGROUND

- 3 The calendar of meetings for 2025 covers the meeting cycle for Council, committee and subcommittee meetings and briefings; and includes other meetings, such as meeting dates for the five community boards.
- While there is no statutory requirement to adopt a calendar of meetings, it is practical and transparent to do so.

HE KŌRERORERO | DISCUSSION

He take | Issues

- In accordance with the Governance Structure and Delegations for the 2022-2025 triennium, the calendar of meetings lists an approximate six to seven-weekly cycle for the Raumati Community Board, which is the same for all other community boards.
- Provisions in the Local Government Official Information and Meetings Act 1987 and Council's Standing Orders prescribe that meeting agendas must be received by meeting participants at least two clear working days ahead of the meeting date. This prescribed standard is exceeded by distributing the agendas five working days in advance of the meeting to give elected members, mana whenua representatives and independent members adequate time to consider the reports and associated information within meeting agendas.

No meetings or briefings have been scheduled for the first week of the school holidays; these periods are shown as 'Keep Free' days. During the second week of the holidays only briefing placeholders have been scheduled on Tuesdays and Thursdays.

Ngā kōwhiringa | Options

Meeting start times

- 8 The first meeting of the Raumati Community Board is set for the first week of March.
- 9 Raumati Community Board meetings are currently scheduled to take place on Tuesday evenings beginning at 7.00pm.
- 10 Community boards are free to decide on a different dates, days and times for their meetings.
- 11 Council, committee and subcommittee meetings, where community board members are participating or voting members, are scheduled to begin at 9.30am on Tuesdays or Thursdays.
- The other community board meetings are currently scheduled to take place on Tuesday evenings at 7.00pm; with the exception of the Paraparaumu Community Board, whose meetings are proposed to begin at 6.30pm on Tuesday evenings.

Briefings, workshops, and training

- Briefings and workshop placeholders have been scheduled on Tuesdays, with some exceptions of placeholders scheduled for a Thursday.
- Briefings and workshops are intended to keep elected members' up to date with key projects and issues and in line with the provisions set in the Local Government Official Information and Meetings Act 1987, decisions must not be made in these sessions.
- 15 Elected member training events will also be scheduled on Tuesdays or Thursdays as required.

Other meetings

- The Appeals Hearing Committee and the District Licensing Committee meet as required and no placeholders are included in the calendar of meetings.
- 17 The draft calendar includes meeting date placeholders for Te Whakaminenga o Kapiti and the other community boards; however, as Te Whakaminenga o Kāpiti and each of the boards are free to set and approve their own meeting schedule, the placeholders may be subject to change.
- Dates for Local Government New Zealand's Zone 4 meetings are not confirmed yet. Zone 4 meetings usually take place quarterly on a Friday.

Changes to the calendar

- Occasionally unforeseen circumstances arise, and it becomes necessary to add, reschedule, or cancel meetings in the calendar. In such cases, the matter is first addressed with the Mayor or Chair of the relevant committee prior to informing elected members about the proposed alternative meeting dates.
- 20 Any changes to meeting dates are publicly communicated through Council's Calendar of Meetings webpage. Elected members are also promptly alerted of changes via Karanga Mai (Outlook) calendar invites, alongside being notified via the weekly Elected Members' Bulletin 'Schedule of Meetings' section. Cancellation notices will include reasons for cancelling.

- 9. The following applications are seeking total funding of \$3,500.00 from the Discretionary Grants Fund.
- 10. Claire Sonntag, on behalf of the Cancer Society of New Zealand Wellington Division Inc., has applied for a grant under the Discretionary Grants Fund of \$750.00 to assist with the cost of garden supplies to maintain the garden and expand fruit and vegetable production at their Kāpiti Support Centre, and the purchase of stackable folding chairs.
- 11. Julia Truscott and Himiona Grace, on behalf Wai Ata Studio, have applied for a grant under the Discretionary Grants Fund of \$750.00 to assist with the costs of staging Rangi Mārie Peace Festival, a community music festival in Queen Elizabeth Park, Paekākāriki on 22 and 23 November 2024.
- 12. Toni Weir, on behalf of the Kāpiti Waldorf Trust (Te Rā School) has applied for a grant under the Discretionary Grants Fund of \$2000.00 to assist with the costs of commissioning a mural on the fence that borders their playgroup and a public walkway in Paraparaumu Beach.

The Paraparaumu Community Board encouraged the applicant to apply to the Raumati Community Board for funding after the Paraparaumu Community Board resolved to decline to fund their application at its meeting of 18 June 2024.

The application was left to lie on the table at the Raumati Community Board meeting of 17 September 2024 pending further discussion with the applicant.

Criteria for Community Grants

The purpose of the Raumati Community Board's Community Grants is to provide financial assistance for projects or activities that promote the wellbeing of the Raumati community and show clear community benefit.

Eligible Organisations/Individuals

- 1. The organisation/individual must undertake its activities in the Raumati area. The Board may consider financial assistance for events occurring outside the Raumati Community where it is shown the community will benefit.
- 2. Eligible organisations include those that provide cultural, sports, environmental or social services to the Raumati areas.

Criteria

- 1. The applicant is unable to receive sufficient grants from other sources.
- 2. The applicant must be non-profit making.
- 3. The organisation/individual must use the financial assistance for its activities in the Raumati Community. The Board may consider financial assistance for events occurring outside the Raumati Community where it is shown the community will benefit.
- 4. Organisations must provide the most recent financial statements and a copy of a resolution noting the decision to apply for funding.
- 5. The organisation/individual has not received financial assistance from the Raumati Community Board Community Grants Fund in the last twelve months.
- 6. Only one application will be considered by an organisation for one event (Individual team member applications will not be eligible).

Please note: All applications must have full documentation to support their application (maximum of five pages in total).

Eligible Purposes:

- 1. Unique or infrequent project or activity;
- 2. Special project or activity;
- 3. Meritorious project or activity;
- 4. To partially or fully offset the cost of any Council permit, licence or resource consent fees*;
- The remission of hall rental*.
- * within the current financial year of the project or activity

Ineligible Purposes

- 1. Expenses incurred for school curriculum activities.
- 2. Retrospective expenses**.

**Grants will not be paid retrospectively other than for hall hire or for the cost of a permit, licence or resource consent fee.

Maximum Grant

The maximum grant payable is \$750.

Accountability

Applicants are required to provide written confirmation or a verbal report that the money was spent for the purpose granted within 2 months of completion of the activity. Individuals are required to outline the benefits gained for them and community groups are required to furnish a written report outlining the benefits gained by the community. In normal circumstances applicants failing to meet accountability criteria will be excluded from any further applications for two years.

The Raumati Community Board requires all monies that are not used for the purpose applied for to be returned to the Community Grants Fund. Failure to do so may exclude the applicant from any further application.

Procedure for Applications

- 1. Applications must be made on the approved application form and must contain all supporting information. Failure to provide all of the required information will result in the application being returned to the applicant.
- 2. Applications must include a bank deposit slip.

The above conditions and criteria do not preclude the Raumati Community Board from considering any application at its discretion.
