#### 4 HE TĀPIRITANGA KI TE RĀRANGI TAKE | ADDITIONAL AGENDA ITEMS

#### **COUNCIL KAUMATUA**

The Heamana raised the matter of beginning the process of appointing council Kaumatua following the retirement of Council's Kaumatua Rakauoteora Te Maipi (Koro Don) for consideration. The Heamana noted that under tikanga, Koro Don would always be welcomed to the table at Te Whakaminenga o Kapiti should he wish to attend after his retirement; and that mana whenua were mindful that council Kaumatua appointments were still to be made.

The Heamana proposed a motion to endorse the Hononga ā-lwi | lwi Partnerships team to commence the Council Kaumatua appointment process. Members discussed the motion and Hara Adams, Te Kaihautū - Hononga ā-lwi | Group Manager lwi Partnerships, answered members' questions.

#### **COMMITTEE RESOLUTION TWOK2025/5**

The Heamana raised the matter of how mana whenua can approach the pre-election process for Kapiti Coast Māori Ward candidates.

Te Whakaminenga o Kapiti members discussed the challenges and opportunities in the preelection process, and options for mana whenua iwi and hapū hosting Kapiti Coast Māori Ward "Meet the Candidate" sessions at marae in the rohe; as well as the poll on the future of the Kapiti Coast Māori Ward

Hara Adams, Te Kaihautū - Hononga ā-lwi | Group Manager lwi Partnerships, and Oriwia Mason, Kaitohutohu Matua Hononga ā-lwi | Principal Advisor lwi Partnerships, answered komiti and elected members' questions.

# TE WHAKAMINENGA O KAPITI REVIEW AND MANA WHENUA REPRESENTATION IN COUNCIL'S GOVERNANCE STRUCTURE

Te Whakaminenga o Kapiti members discussed mana whenua representation arrangements within Council's existing Governance Structure, and the review of Te Whakaminenga o Kapiti currently underway to ensure the partnership body upheld Council's partnership with mana whenua, and how this could be enhanced. The review was anticipated to be completed in time for the 2025 elections.

The update on the celebrations planned for the 30-year anniversary of Te Whakaminenga o Kapiti did not take place.

#### 7 HE KŌRERO HOU MŌ NGĀ IWI | IWI UPDATES

Rawiri Tawhai-Bodsworth advised that Ātiawa ki Whakarongotai would be attending the Proposed Plan Change 3 - Kārewarewa urupā hearings to support their submission on incorporating Kārewarewa urupā into Schedule 9 of the District Plan (Sites and Areas of Significance to Māori). Mr Tawhai-Bodsworth spoke to the significance of Kārewarewa urupā to Ātiawa ki Whakarongotai and mana whenua, and noted past decisions made by previous local authorities and crown entities to permit housing developments on parts of the urupā. The hearing dates for the Proposed Plan Change 3 are to be confirmed, but are likely to take place in April or May 2025.

The Heamana noted that the Kapiti Coast Māori Ward was currently a matter of high importance for Ngā Hapū o Ōtaki, and that dates for the iwi forums in 2025 were still to be set.

# 8 NGĀ WHAKATAUNGA TIRITI - HE TIROHANGA WHĀNUI NŌ IA IWI | TREATY SETTLEMENTS – OVERVIEW FROM EACH IWI

There were no updates provided on Te Tiriti settlements at the hui.

### 9 HE KŌRERO HOU MŌ TE KAUNIHERA | COUNCIL UPDATE

Deputy Mayor Lawrence Kirby acknowledged the mahi undertaken by Ngā Hapū o Ōtaki to hold the Waitangi ki Taumanuka 2025 commerations on Te Rā o Waitangi (Waitangi Day). The Heamana thanked Karly Richardson, Kaitohutohu o ngā Kaupapa ā Iwi | Advisor Iwi Projects, and Pania Rei, Te Kaitohutohu - Hononga-a-Iwi | Iwi Partnerships Advisor, for their mana enhancing approach to working with Ngā Hapū o Ōtaki to organise the Waitangi ki Taumanuka 2025 commerations; and also thanked Rebecca Rolls, Civic and Community Events Coordinator, and Raen Fraser, Te Kaitohutohu Matua Whakapātanga me te Paheko | Senior Advisor Communications and Engagement, for their mahi.

The Mayor acknowledged the Farrell whānau and Ngāti Haumia following the recent loss of Kaumatua Karl Farrell. The Mayor noted that the work towards provision of compensation for the land confiscated from Ngāti Haumia would continue, and the Heamana noted the potential for the A.R.T. Confederation to have a role in the kaupapa.

#### 10 HE TONO ANAMATA MŌ TE RĀRANGI TAKE | FUTURE AGENDA REQUESTS

The Heamana requested agenda requests from mana whenua be provided to the lwi Partnerships team ahead of the publication of the agenda for the next Te Whakaminenga o Kapiti meeting.

#### 6.1 LOCAL BODY ELECTIONS 2025 - INDUCTION AND INAUGURATION CEREMONY

# TE PŪTAKE | PURPOSE

To provide the members of Te Whakaminenga o Kapiti with an update on the planned induction phase and inaugural meeting which will follow the local body elections, and to provide an opportunity to discuss the venue and format of the inauguration ceremony and mana whenua involvement in the formalities of the evening.

# TŪĀPAPA | BACKGROUND

- In line with the Local Electoral Act 2001 (LEA), Council is required to hold local body elections every three years with the next election day falling on 11 October 2025. The process and timing for the election is determined by the LEA and the Local Government Act 2002 (LGA) which set the timetable for the conduct of the elections and the processes for the inaugural meetings of Council and the community boards after the elections.
- This election cycle, in addition to the election of the councillors (including one Māori ward councillor) and community board members, will also include polls on whether the Kapiti Coast Māori Ward and Te Upoko o te Ika a Māui Māori Constituency (Greater Wellington Regional Council Māori constituency) should remain in place for the 2028 and 2031 local body elections.<sup>1</sup>
- Once the new Council and Community Board members are elected, an induction period will commence. This period commences after the final election and poll results are declared and will run until Council breaks for the Christmas period in mid-December (the last meeting of Council is scheduled for 11 December 2025). The induction phase will contain relevant briefing and training sessions which serve to ensure that elected members are provided with the right tools, guidance, information and knowledge to discharge their roles and responsibilities.

## HE TAKE | ISSUES

Newly elected members will come into office the day after the final results are publicly notified in line with the LEA.<sup>2</sup> As part of the induction period, before elected members can officially act in their roles as elected members, they must be sworn in by making a declaration of office. As per the provisions of the LGA, this must occur at an inaugural meeting ('the inauguration') which is set for Thursday 30 October 2025.<sup>3</sup> This ceremony must also include the election of appointment of the Deputy Mayor and the explanation of relevant information and has traditionally also included a pōwhiri led by mana whenua.

<sup>&</sup>lt;sup>2</sup> Under the LEA, the latest date is 19 October 2025.

<sup>&</sup>lt;sup>3</sup> In line with the LGA, the inaugural meeting must be notified not less than 7 days in advance of the meeting. If election results are publicly notified by 19 October 2025 (latest date), the earliest date the inaugural meeting could take place is Monday 27 October 2025 which coincides with Labour Day. Council has traditionally held its inauguration ceremony on a Thursday evening so Thursday 30 October 2025 was chosen as the date for the inaugural meeting of Council. A back-up date of 27 November has also been identified in case a recount of the elections is requested through the Courts.

# NGĀ KŌWHIRINGA | OPTIONS

- The inauguration ceremony following the 2022 local body elections took place at Te Raukura ki Kāpiti. The upcoming ceremony can once again be booked at Te Raukura ki Kāpiti considering the venue meets all of the requirements including space for a celebratory drink and kai after the conclusion of the formalities as well as the ability to livestream the meetings.<sup>4</sup>
- 7 Alternatively, other venues to hold the ceremony can be discussed and explored.

#### MANA WHENUA

8 Mana whenua are encouraged to discuss involvement in the inauguration ceremony by providing input into an appropriate venue and format of the ceremony and by supporting the pōwhiri and joining in the celebrations after the formalities have concluded

# NGĀ MAHI PANUKU | NEXT STEPS

Any input provided will be taken into consideration and will support the planning of the overall induction phase and the inauguration ceremony. Once a more detailed plan has been developed, this will be further socialised with Council's mana whenua partners.
