What is a Speed Management Plan?

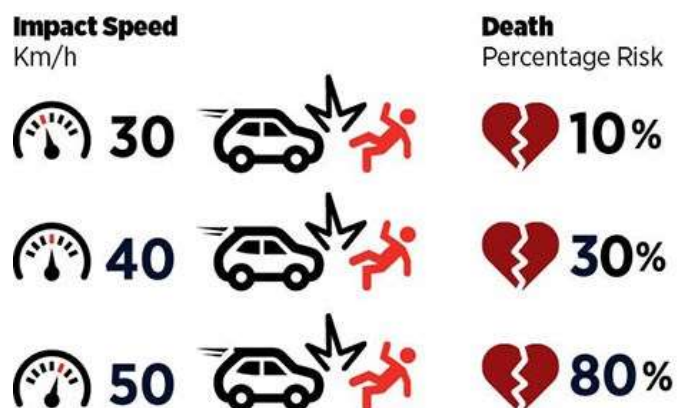


- 10-year vision
- 3 x year Implementation Plan
- Every 3 years

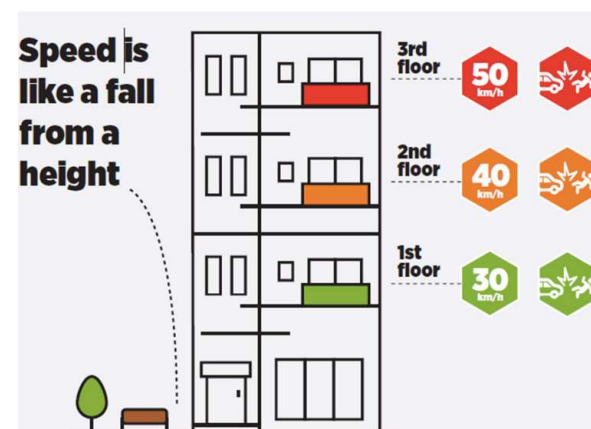
Safe and appropriate speed limit = Survivability

A **safe and appropriate speed** limit is a speed limit that gives the best chance of survival without serious injury to anyone involved in a crash

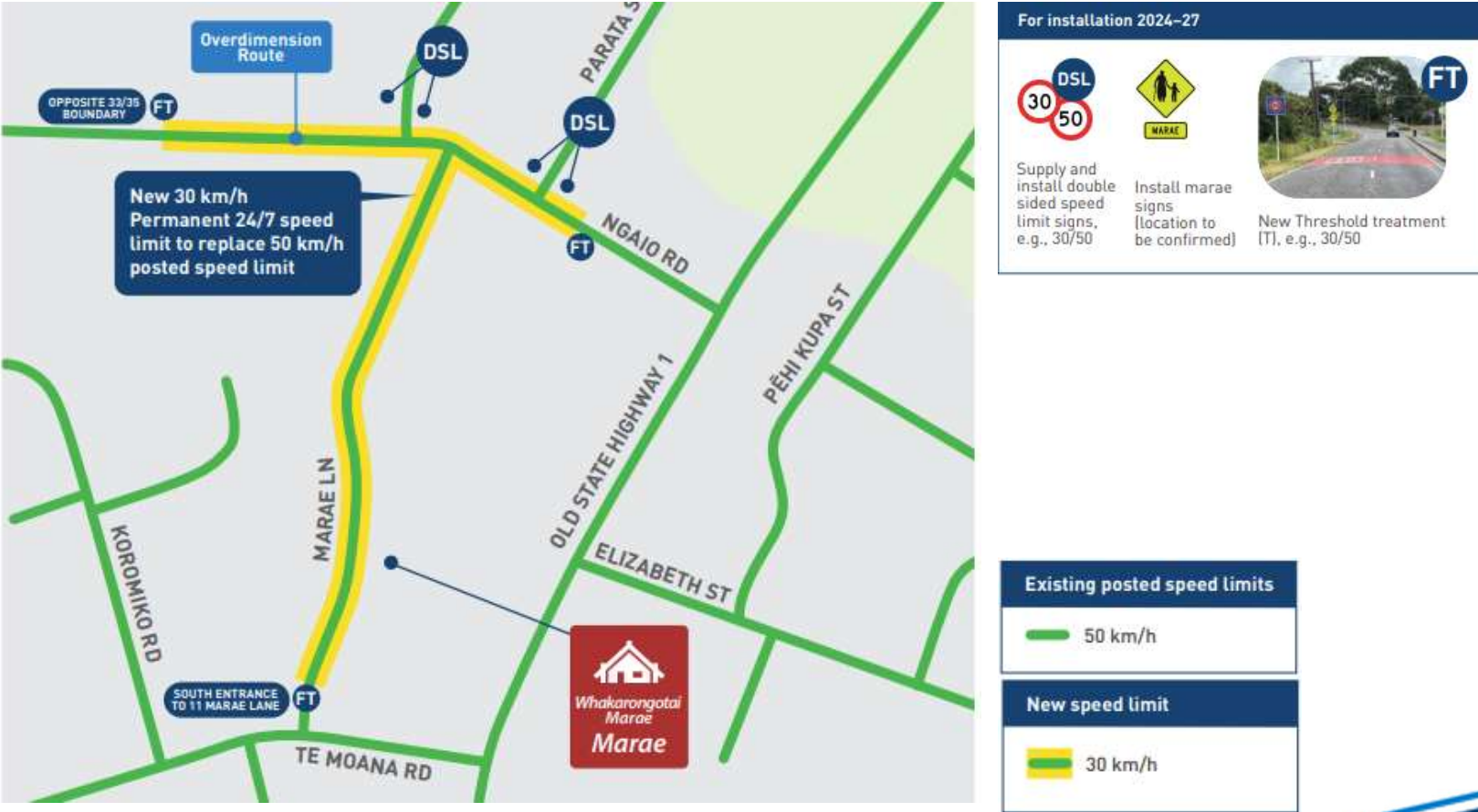

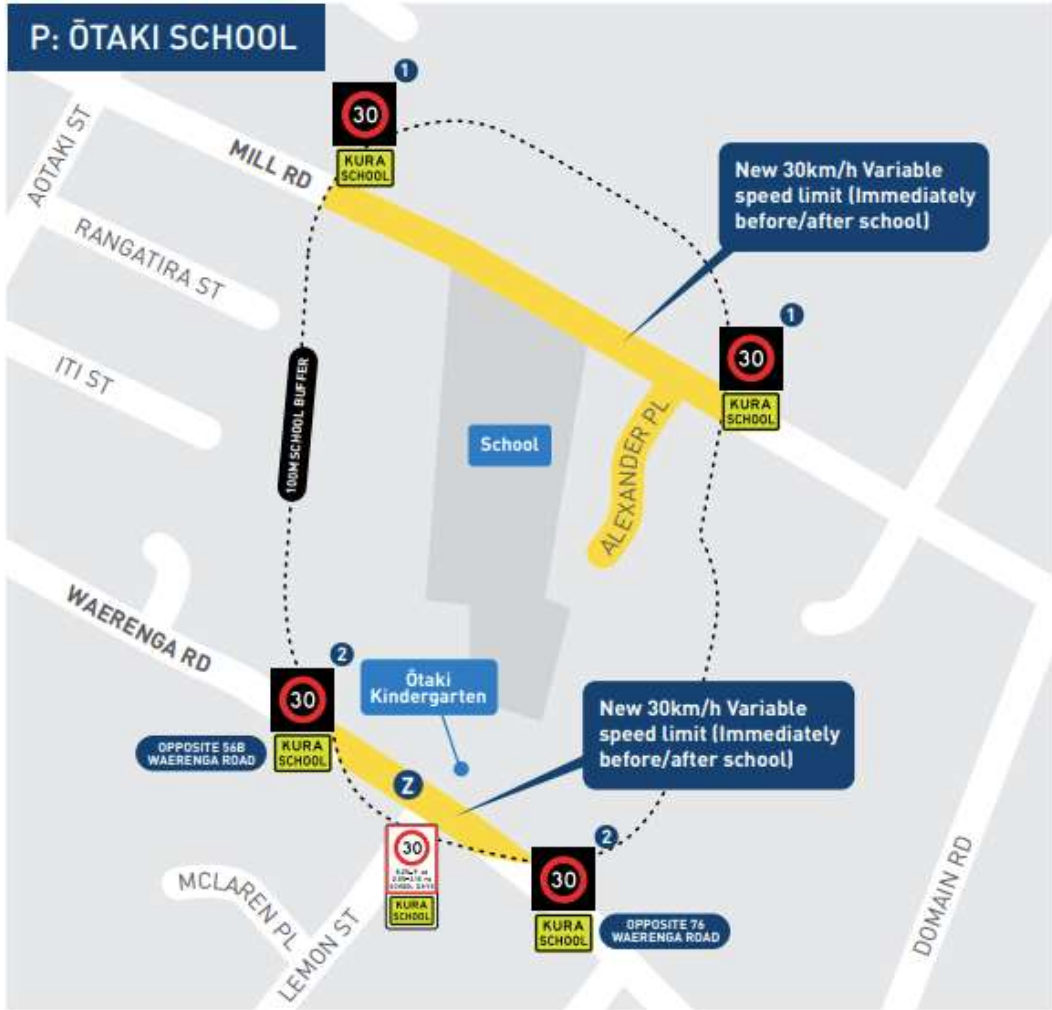
