6.1 UPDATE ON MACLEAN PARK SKATE PARK

TE PŪTAKE | PURPOSE

1 To provide the Paraparaumu Community Board with an update on Maclean Park Skate Park project.

TAUNAKITANGA | RECOMMENDATIONS

A. Note the content of this update.

TŪĀPAPA | BACKGROUND

- The upgrade of Maclean Park skate park was initiated through the community engagement on the Maclean Park Management Plan in 2018. Funding for the upgrade was provided for in the 2021-41 Long Term Plan.
- In April 2022, Council commenced the upgrade of the skate park, beginning with engagement with skate park users to understand what features the community desired in a new park. The Council's Project Management Office is leading the project on behalf of the Parks, Open Spaces and Environment team.

HE TAKE | ISSUES

Design

The skate park designer Rich Landscapes has developed the design, incorporating feedback from the community and with close engagement with an expert user group. The final design includes a range of features seen in modern skate parks that will enable users to progress from learner to expert and allow for more people to enjoy the skate park at one time, including additional seating and shelters.

Art

- The Council has engaged artist Kereama Taepa to provide concept art to be incorporated into the exterior walls of the skate park. Kereama created the Tohorā sculpture and Aramoana pattern on the concrete walls that were installed as part of the last upgrade project at the park and is continuing that theme along the skate park walls and a steel balustrade which could be lit at night.
- The artwork and elements of the design have been reviewed by members of Te Ātiawa ki Whakarongotai.
- Rich Landscapes are now updating the engineering details to take account of the proposed artworks.

Lighting

- 8 Council has engaged a lighting designer to provide an assessment of the current lighting provision at the skate park and design potential solutions. Preliminary advice is that the current lighting would be inadequate for the western side of the skate park.
- 9 It is likely that will need to install up to three additional poles along the western side to provide a safe environment for park users. The light poles would be smaller in height than the existing two on the eastern side, and we will look to ensure that any additional light fittings create minimal spill to nearby residents. The additional poles may also provide an opportunity to light

the path behind the skate park which is an issue that was raised by park users during the engagement.

Resource Consent

10 Council applied for resource consent for the skate park project in October, as the volume of earthworks required and building coverage of the skate park shelters exceeds the permitted standard. A decision on the consent is expected to be granted in December.

Construction

11 Construction of the new skate park is expected to commence in April 2024 with expert skate park builders Angus McMillan Concrete. Demolition of the existing park and preparation of the site will need to occur before construction begins. We are planning to use a local contractor to perform this work, likely beginning in March 2024. The skate park will need to be fenced off from this time and unable to be used for approximately five months until the build is complete.

PARAPARAUMU COMMUNITY BOARD COMMUNITY GRANTS APPLICATION FORM

Criteria for Community Grants

The purpose of the Paraparaumu Community Board's Community Grants is to provide financial assistance for projects or activities that promote the wellbeing of the Paraparaumu community and show clear community benefit.

Eligible Organisations/Individuals

- 1. The organisation/individual must undertake its activities in the Paraparaumu area. The Board may consider financial assistance for events occurring outside the Paraparaumu Community where it is shown the community will benefit.
- 2. Eligible organisations include those that provide cultural, sports, environmental or social services to the Paraparaumu areas.

Criteria

- 1. The applicant is unable to receive sufficient grants from other sources.
- 2. The applicant must be non-profit making.
- The organisation/individual must use the financial assistance for its activities in the Paraparaumu Community. The Board may consider financial assistance for events occurring outside the Paraparaumu Community where it is shown the community will benefit.
- 4. Organisations must provide the most recent financial statements and a copy of a resolution noting the decision to apply for funding.
- 5. The organisation/individual has not received financial assistance from the Paraparaumu Community Board Community Grants Fund in the last twelve months.
- 6. Only one application will be considered by an organisation for one event (Individual team member applications will not be eligible).

Please note: All applications must have full documentation to support their application (maximum of five pages in total).

Eligible Purposes:

- 1. Unique or infrequent project or activity;
- 2. Special project or activity;
- 3. Meritorious project or activity;
- 4. To partially or fully offset the cost of any Council permit, licence or resource consent fees*;
- 5. The remission of hall rental*.
- * within the current financial year of the project or activity

Ineligible Purposes

- 1. Expenses incurred for school curriculum activities.
- 2. Retrospective expenses**.

**Grants will not be paid retrospectively other than for hall hire or for the cost of a permit, licence or resource consent fee.

PARAPARAUMU COMMUNITY BOARD COMMUNITY GRANTS APPLICATION FORM

Maximum Grant

The maximum grant payable is \$750.

Accountability

Applicants are required to provide written confirmation or a verbal report that the money was spent for the purpose granted within 2 months of completion of the activity. Individuals are required to outline the benefits gained for them and community groups are required to furnish a written report outlining the benefits gained by the community. In normal circumstances applicants failing to meet accountability criteria will be excluded from any further applications for two years.

The Paraparaumu Community Board requires all monies that are not used for the purpose applied for to be returned to the Community Grants Fund. Failure to do so may exclude the applicant from any further application.

Procedure for Applications

- Applications must be made on the approved application form and must contain all supporting information. Failure to provide all of the required information will result in the application being returned to the applicant.
- 2. Applications must include a bank deposit slip.

The above conditions and criteria do not preclude the Paraparaumu Community Board from considering any application at its discretion.

This report provides details of a proposal to install a loading zone adjacent to the property at 15 Seaview Road with associated line marking and signage. The installation of the loading zone will require the removal of one on street car parking space. The adjoining business owners have been consulted and this report will detail the feedback received as part of this consultation.

TAUNAKITANGA | RECOMMENDATIONS

That the Paraparaumu Community Board approve:

- A. A Loading Zone be installed adjacent to 15 Seaview Road. The zone is to be restricted to Goods Vehicles Only, Monday to Saturday, 8am to 6pm time restricted to 15 minutes. The loading zone will be available for public parking outside of these times.
- B. The zone to be installed in accordance with the Traffic Control Devices Manual Part 13 Parking Control with the yellow line marking and Loading Zone lettering to be in accordance with The Manual of Traffic Signs and Markings Part 2 Section 2.12.04 and Figure 2.15. A Location Plan and sign details are included in Attachment 1 of this report.

TŪĀPAPA | BACKGROUND

- The trigger for this proposal was a request from elected members who were approached by a local delivery driver who suggested that loading zones within the Paraparaumu Beach Town Centre were required to ensure that deliveries could be undertaken efficiently and safely.
- An onsite meeting was arranged between elected members, Council Officers, the delivery driver requesting the loading zones and one of the Paraparaumu Beach business owners. At this meeting appropriate locations were discussed with officers giving an undertaking that two locations would be further investigated. One of these locations was adjacent to 15 Seaview Road (see below) which is the subject of this report and the other was a loading zone adjacent to 33 Marine Parade which is the subject of a separate report also being considered at this meeting.



- Officers reviewed the location adjacent to 15 Seaview Road from a safety and efficiency perspective and considered that this would be the most appropriate location within the immediate vicinity for the following reasons:
 - The installation will only require the removal of one on street car parking space.
 - The Marine Parade location is the most suitable within the immediate area and this site
 compliments the Marine Parade location as it will service most of the businesses along
 Seaview Road and the eastern side of MacLean Street. This location was supported
 by the delivery driver who initially requested two loading zones be installed within the
 Paraparaumu Beach area.
 - The area has sufficient dimensions for larger delivery vehicles to safely access the loading zone. The access to the rear of the shops and broken yellow lines allow additional space for vehicles to manoeuvre without having to remove more than one on street car parking space.
 - Council Transport Safety Lead has undertaken an assessment and supports the location from a traffic safety point of view.
- There are no dedicated on-street loading zones on any Kāpiti Coast roads which is an increasing issue as our town or village centres thrive and the need for servicing increases. Deliveries to the Paraparaumu Beach Town Centre are currently causing safety concerns with drivers double parking or parking on broken yellow lines. Vehicles often park in inappropriate places around the Marine Parade/ MacLean Street intersection as there is limited on and off-street areas for deliveries to be undertaken.
- 8 Council Officers are also dealing with a similar issue in Raumati where a loading zone was considered adjacent to 22 Raumati Road for the use of business within the Raumati Town Centre. Parking for delivery vehicles is a district wide issue and although Council is currently

dealing with these reactively it is proposed to address this issue through car parking management strategies for other commercial areas in the future.

HE KÖRERORERO | DISCUSSION

He take | Issues

The main issue within the Paraparaumu Beach Town Centre is the lack of any parking spaces large enough to accommodate large commercial vehicles which has led to unsafe and illegal parking. The task was then finding the best options which looked at road safety and commercial practicality, balancing commercial servicing against customer access.

Ngā kōwhiringa | Options

- To limit the impact upon the available parking within the area it is proposed to restrict the loading zone to between normal business hours 8am to 6pm Monday to Saturday have this space available for public parking outside of these times. The loading zone will be 7.5m in length.
- There are a number of other locations that could be suitable within the Paraparaumu Beach Town Centre area for the installation of a loading zone, but these would generally require the removal of more than one car parking space and are not optimal in relation to the proximity to the majority of businesses within the town centre.
- Other appropriate locations have been looked at but were found to be generally unworkable or less desirable for a loading zone. These specific locations are summarised in Table 1 below:

Mana whenua were not consulted for this report. The provision of a loading zone will provide benefits to the commercial hub in Paraparaumu Beach Town Centre as a whole including mana whenua.

- Having a loading zone increases the efficiency of deliveries to the local businesses and commercial areas in general. Where delivery vehicles are currently parking creates parking, access and safety issues. Loading zones will ensure they can park safely and not add to congestion in the area.
- 15 It will provide a dedicated goods vehicle only area which should reduce the need for delivery vehicles having to circle the area wasting fuel looking for a parking space.
- The loading zone will also improve road safety on Marine Parade, MacLean Street and Seaview Road which benefits pedestrians and cyclists accessing the town centre thus improving accessibility and promoting sustainable travel.

TE WHAKAWHITI KŌRERO ME TE TŪHONO | COMMUNICATIONS & ENGAGEMENT

Te mahere tühono | Engagement planning

- 20 An engagement plan is not needed to implement this decision. Council has already consulted with affected parties.
- 21 Feedback was sought from the business owners of 15 Seaview Road, Ben's Roasts, 17 Seaview Road, Spice Lounge and 19 Seaview Road, Paraparaumu Beach Pharmacy. No response was received from the owners of Ben's Roasts or Spice Lounge. The owner of Paraparaumu Beach Pharmacy opposes the removal of the car parking space. This feedback has been attached to this report in Attachment 2.
- The concerns the Pharmacy raised were in relation to removing car parking for delivery vehicles. Their submission stated 'we get 4 to 5 regular deliveries a day and our couriers have no problem for parking for a few minutes'. The pharmacy also believes there is a need for more parking within the area and their business has many disabled customers who struggle to find parking spaces near the pharmacy. Lastly, the submission mentioned that the block of shops has been purchased by a developer who will be looking to redevelop the land shortly. Council has no information regarding the redevelopment of this site.
- With regards to the loss of one car parking space it is considered that the benefit of providing a load zone where delivery vehicles can safely load and unload their goods outweighs the negative impacts of losing one car parking space within the town centre. There is obviously a need for loading zones, these have been requested by delivery drivers and some businesses. Officers have been made aware of delivery vehicles parking illegally and creating a traffic safety concern. There is a disabled car parking space directly oppose the pharmacy and there is time restricted parking within the town centre that should discourage business owners and staff from parking in these spaces all day. Also, the car parking space and loading zone will no be directly outside of the Pharmacy.
- Other options have been investigated as per Table 1 however the 33 Marine Parade and 15 Seaview Road locations are the most appropriate and desirable. Ben's Roasts and Spice lounge will be the most affected business as a result of the installation of the loading zone and no feedback was provided by these businesses. After 6pm the loading zone could be used by the public for parking.

2.12.04 LOADING ZONE

Where the road surface is suitable, loading zones are to be marked on a section of road that the road controlling authority has authorised to be reserved for a loading zone.

Loading zones shall be marked in conjunction with RP-7, RP - 7.1 or RP - 7.2 signs as defined in PART I of this manual.

Loading zones shall be marked as follows:





- An engagement plan is not needed to implement this decision. Council has already consulted with affected parties.
- 21 Feedback was sought from the business owners of 33 Marine Parade, Driftwood Superette and 36 Marine Parade, Ambience Café. The owner of Driftwood Superette supported the loading zone in the proposed location, but the owner of Ambience Café requested Council look at an alternative. This feedback has been attached to this report.
- Council also received an email from a local resident who lives in the Shoreline Apartments in support of the Driftwood Superette submission also attached.
- Ambience Café has a trading in public places permit which allows them to have three tables with two chairs each setback 1m from the kerb on the footpath. A copy of the permit has been attached to this report. This permit expires on 23 December 2023. The concern raised was that vehicles using the loading zone would impact the amenity and enjoyment of Ambience customers, loss of business and that the loading zone could result in safety issues.
- Council's Transport Safety Lead has assessed any potential safety impacts relating to this location and is satisfied that there are no significant safety issues that would warrant the reconsideration of the proposal. The zone will have a length of 9m which will allow vehicles accessing the space to enter in a forward's direction with minimal manoeuvring required for vehicles to park sufficiently. The 1m setback provides a buffer between the tables and the kerb and it is very unlikely that vehicles would mount the kerb when parking. It would be the responsibility of the delivery staff to ensure that loading and unloading of goods is done safely. It is considered that the dimensions of the loading zone will accommodate the majority of delivery vehicles who service the Paraparaumu Beach Town centre.
- With regards to the amenity of customers and impacts upon trade it is expected that delivery vans will be the vehicles that predominantly use the loading zone however it has been designed for larger vehicles as well. The space will be time restricted to 15 minutes and will only be parked in the space while loading and unloading. There is currently a car parking space adjacent to the tables which will be retained. Although, it could be expected that there is an additional vehicle parked adjacent to the seating it is considered that the impact upon the amenity of dinners will not be unreasonable and what could be expected for seating located adjacent to a road.
- Ambience Café mentioned that their customers frequently use the bicycle parking. It is important to note that there are bicycle stands located directly outside the Driftwood Superette along the MacLean Street frontage. The Access and Transport team have assessed appropriate locations to relocate the bicycle parking and it was determined that there is sufficient space within MacLean Park. The plan below illustrates this location and where the existing bicycle parks outside the Driftwood Café are sited. The site within the park is approximately 20m from the current location and has the advantage of being closer to the MacLean Park shared path which is considered a safer and more convenient location for cyclists to dismount and park.



Location of relocated bicycle parking



- 8. Permitted Use/Activity this licence is issued to enable outdoor dining on public land*.
 - *If this licence relates to 'Outdoor Dining' it does not enable the consumption of alcohol in isolation of outdoor dining. The licensee must comply with the provisions of the Sale and Supply of Alcohol Act 2012 and any conditions associated with its alcohol licence.
- The licensee indemnifies the Council against any claim for damages or compensation arising out of the licensee's use of the licensed area.
- 10. A copy of this licence and approved plan must be made available to an authorised officer on request.
- 11. The licensed area consists of an approximately 8 metres by 5 metres area more precisely identified as outlined in the plan dated and stamped as approved by Council on 23 December 2021.
- 12. The licence permits the placement of two tables with two chairs at each adjacent to the building, and three tables with two chairs at each adjacent to the curb only.



7.4 PARAPARAUMU BUS STOP IMPROVEMENTS

TE PŪTAKE | PURPOSE

This report provides the details of proposed bus stop marking upgrades within the Paraparaumu Community Board area for the Route 262 and 264 Bus Services. These upgrades are line marking improvements which the Greater Wellington Regional Council (GWRC) have consulted on and are now requesting Kapiti Coast District Council (Council), as the Road Controlling Authority, to implement.

HE WHAKARĀPOPOTO | EXECUTIVE SUMMARY

TE TUKU HAEPAPA | DELEGATION

- 2 Section D of the 2022-2025 Triennium Governance Structure and Delegations gives the Community Board the authority to consider these matters:
 - "...Authority to approve or reject officer recommendations relating to traffic control and signage matters for existing local roads, except those matters that involve significant safety issues. Community Boards will be consulted about these matters, but final delegation will rest with Council officers."

TAUNAKITANGA | RECOMMENDATIONS

A. That the Paraparaumu Community Board recommends approval of the proposals put forward by the GWRC and approved by Council Transport engineers as detailed in Table 1 and Appendix 1 of this report. This will bring the selected bus stops on Routes 262 and 264 up to recommended industry standard which provides for safer access and visibility at these bus stops.

TŪĀPAPA | BACKGROUND

- 3 GWRC has a multi-year plan to review and carry out improvements to all (approximately 3000) bus stops across the Wellington Region.
- GWRC's bus stop improvement programme gives effect to the Wellington Regional Public Transport Plan 2021 2031. The strategic priority is to achieve an efficient, accessible, and low carbon transport. These strategic policies align well with that of the Council, particularly by improving the customer experience for public transport users and helping to improve patronage.
- 5 GWRC are focussed on continuing to improve the customer experience across the network by:
 - Improving access for patrons by ensuring buses can pull in close to the kerb for safe passenger boarding and alighting and the ability for the wheelchair ramp to be deployed when needed.
 - Improving safety at bus stops by ensuring buses can access bus stops while minimising the impact on following vehicular traffic.
 - Installing new bus shelters and renewing existing older shelters that have poor functionality and don't offer good weather protection.
- From mid-2018 GWRC awarded new bus contracts across the Wellington Region. These new bus contracts introduced a fleet of modern lower emission buses. These new buses allow full disability access and include space for mobility aids, prams, and luggage, as well as bike racks, to better meet a range of customer and community mobility needs. These new

- contracts have also introduced larger buses on some high demand services to cater for growing customer demand.
- While new buses are designed to be fully accessible for customers, they are only accessible where the bus can pull up parallel to the kerb allowing customers step-free access to the bus. This is particularly critical for customers with wheelchairs or other mobility aids, as well as customers with prams or wheeled luggage, where having to step out into the roadway and then up into the bus is a barrier to access.
- The package of work for Routes 262 and 264 consists of twelve bus stops in the Paraparaumu Community Board's jurisdiction. The bus stop changes proposed in this report comprise of lengthening bus stops to improve safety by installing painted bus boxes and broken yellow lines before and after stops, as well as relocating some stops which cannot be made safe

HE KÖRERORERO | DISCUSSION

He take | Issues

All of the bus stops in this upgrade are existing stops, some with shelters, but mostly they are simply defined by the regulatory bus stop signage on a standalone pole or attached to existing utility poles. Very few of them currently have bus boxes painted on the road and are only protected by Sec 6.8 of the Land Transport (Road User) Rule 2004 which states "A driver or person in charge of a vehicle must not stop, stand, or park within 6 metres of a bus stop sign.". This rule is not well observed, and vehicles regularly park over or park too close to bus stops. Even parking within 6 metres either side of a bus stop sign is not going to allow an 11m long bus room to pull into the kerb safely.

Ngā kōwhiringa | Options

- In September 2022 new *Bus Stop, Public Transport Design Guidance* was published by Waka Kotahi NZ Transport Agency. Appropriate layout of bus stops is essential to supporting the safe, efficient, and accessible operation of bus services. The key component of a successful bus stop is that the bus can reliably and consistently align close and parallel to the kerb and stop where passengers expect it to stop relative to the bus stop sign, shelter, footpath indicators, or road markings. A failure to align the bus with the kerb properly is often for one of two reasons:
 - the bus driver deliberately stops far away from the kerb to make it easier to pull out of the bus stop or
 - the kerb or bus stop layout forces the driver to pull in or out of the bus stop at too sharp an angle.

Either reason can have serious implications for the bus service being accessible and safe.

- 11 Kerbside bus stops are the most common bus stop layout for most urban and suburban streets in New Zealand. Lead-in and lead-out space is required where the bus needs to pull out of and back into the kerbside traffic lane because of an obstruction, usually on-street parking. When on-street parking is too close to a kerbside bus stop, the bus may have trouble entering and exiting the stop and aligning close and parallel to the kerb.
- The recommended dimensions, in the guidance, for a kerbside bus stop for a standard 13.5m bus with mounted bike rack and parking on either side is identified as having a 15m entry taper, a 15m long bus box, and a 9m exit taper. The entry and exit tapers being no parking areas marked with broken yellow lines.
- The bus stop dimensions proposed by GWRC differ slightly to this, having a shorter 9m entry taper. This is due to the WK guidance only recently having been released when there was previously no national guidance, and each local authority or regional authority used its own local rules. Updating to the longer entry taper would result in the loss of another car park and differ from what had been consulted on with residents.

Mana whenua

15 Mana whenua were not consulted for this report. Improvements to the bus stops will provide benefits to the whole community including mana whenua.

Panonitanga Āhuarangi me te Taiao | Climate change and Environment

The upgrading of our bus stops is a positive step toward making our public transport system more accessible to the public and therefore promoting more use of the services which reduces private car use.

- 17 Having easier access to bus stops for buses increases the efficiency of the service and the network in general. Where buses may previously have had to park in a live lane due to parking issues they can now pull in safely and not add to congestion on the roads.
- Having correctly sized bus stops helps future proof the network for the use of electric buses. A few electric buses have already been trialled in Kapiti and they have tended to be larger sized buses so it is advantageous to install correctly sized stops

Ahumoni me ngā rawa | Financial and resourcing

There are no financial implications as the cost of the line marking is accommodated in current roading budgets. This is a rolling programme of upgrades instigated by GWRC with one or two routes being completed each financial year which spreads the financial load. All engineering assessment, consultation, signage and shelter costs are borne by GWRC.

Türaru ā-Ture me te Whakahaere | Legal and Organisational Risk

- There are no identified legal and organisational risks, all new signs and road-markings are installed in accordance with New Zealand Transport Agency Guidelines and New Zealand Traffic Regulations.
- The Council has the power to establish a Transport Bylaw under the Land Transport Act 1998 and through this Bylaw has the power to impose or modify parking restrictions. Section 6.2 b) of the Bylaw allows for a resolution to Limit the stopping or parking of vehicles on any road to vehicles of any specified class or description; i.e buses. There is no requirement for consultation or process for objection.
- However the provision of a physical Bus Shelter is a different matter and this is covered by Section 339 of the Local Government Act 1974 and there is a formal notification and objection process to be followed.

Ngā pānga ki ngā kaupapa here | Policy impact

There are no policy implications in relation to this work. This is in line with the Council Sustainable Transport Strategy 2022 which seeks to promote and improve sustainable travel throughout the district. It helps to fulfil the outcomes of "Improved access, connectivity and integration; resilient transport network; and addressing climate change.




















PROPOSED BUS STOP LAYOUT CHANGES **KAPITI ROAD - STOP #1194 AND #1102**

Town Centres Project/ Paraparaumu Transport Hub	A joint project between Kāpiti Coast District Council and Metlink to improve users' public transport experience and better connect the Paraparaumu Transport Hub to the retail centre has commenced. Works involve building a larger and more convenient bus interchange set within a landscaped, fully accessible public plaza and the design allows commuters to move between the train and bus while remaining undercover. Repeating elements such as concrete paving, seating and cultural works will feature within the plaza on both sides of the road (Old State Highway 1). It'll help make the whole area look and function like one extended space separated by a controlled pedestrian crossing. The footpath leading to Kāpiti Lights will be widened and improved and the pedestrian underpass will remain in place. Metlink are installing their first distinctive living-roof bus shelters. The shelters will also incorporate public transport infrastructure such as Real Time Information displays and signage designed to ensure easy wayfinding for passengers. Work is well underway and progressing however we have experienced some delays with finalizing the GWRC living earth shelters and their foundations.
CCTV on Council's Parks and Open Spaces	An analysis on Council's CCTV network is being looked into and a report will go to the Council in the new triennium and the Community Board will be updated after.
The following items are part of the Council's forward work programme (for noting and appropriate updates)	
Te Newhanga Kapiti Community Centre	Council has engaged a provider to deliver a social and community needs assessment so that any future development is fit for purpose. An engineering company has been engaged to carry out further structural assessments of the building to better understand future options. In the meantime the outside of the building areas have been maintained.
MacLean Park (skate park, amenity block, lights at the basketball court)	 The Martin Kaukau memorial is being incorporated into the skatepark Procurement is underway with amenity block suppliers to deliver more toilets (increase from the current 3 to 6 toilets), and a fully accessible 'Changing Places' facility for high needs users. We have experienced some delays with consenting, so have delayed the start of the amenities build until Feb 2024 to avoid disruption during the summer holidays. There will be additional landscaping to link the amenity block and the skatepark and provide an entrance to the park from the pedestrian crossing. The Council are engaging separately with Te Ātiawa ki Whakarongotai and Ngāti Toa to ensure mana whenua and rangatahi have input where appropriate, in particular how artwork and storytelling are incorporated in the design. The storytelling is currently being scoped by council officers. The aim is for the Stage 2 development to be complete by June 2024. The bridge over the Tikotu stream was removed as part of the stream upgrades. The previous bridge that was removed was designed to allow floodwater to spill over and through the structure. It was non-complying from an accessibility perspective and would not meet current minimum

	standards if it was simply replaced. The bridge was towards the end of its design life and was planned to be replaced with a new bridge which was designed to be integrated into the proposed Te Uruhi building's deck.
	With the Te Uruhi project not proceeding there is no design, consent and funding available for the bridge replacement. The widening of the adjacent footpath has previously been looked at as an effective alternative to a bridge and could be delivered as part of the proposed culvert upgrade works.
