Mr Richard Evans, Ātiawa ki Whakarongotai, spoke regarding the status of the Kawakahia/Te Harakeke wetlands. Mr Evans advised that the Kawakahia/Te Harakeke wetlands, a native habitat for many species, is in danger from pollution and climate change, and requires enduring protection.

Hara Adams noted she would begin discussions with Brendan Owens, Group Manager Customer and Community, regarding the matter.

He Heamana Kim Tahiwi noted that the committee would consider making a recommendation to Council regarding this matter and would return to the item at a later point in the hui.

Kris Pervan, Group Manager Strategy and Growth and Gina Anderson-Lister, Manager Strategy, introduced the report, took it as read and answered questions from members.

#### 6.2 MĀORI ECONOMIC DEVELOPMENT FUND 2024-25

Karly Richardson, Advisor Iwi Projects, and Hara Adams, Kaihautū - Hononga ā-Iwi | Group Manager Iwi Partnerships, introduced the report and took it as read. Ms Richardson, along with Hara Adams, discussed the latest round of grant applications and answered questions from members.

Ms Adams acknowledged and thanked Karly Richardson for her mahi on the report and during the process, noting that this year was the fund's most well subscribed.

Ms Adams also noted that the lwi Partnerships team would work on bringing a report to a future meeting of Te Whakaminenga o Kapiti containing recommendations on how to progress point 14 in the report, specifically in regards to revisiting the Terms of Reference.

#### 6.3 PARTNERSHIP AGREEMENT

Oriwia Mason, Kaitohutohu Matua Hononga ā-lwi I Principal Advisor and Hara Adams, Kaihautū - Hononga ā-lwi | Group Manager lwi Partnerships, provided an update on the final version of the partnership agreement.

Ms Mason advised Te Whakaminenga o Kapiti that the partnership agreement was scheduled on the Council hui agenda this Thursday, 19 June 2025, for endorsement and the final design would be finished ahead of the official signing on Friday 27 June 2025 at Raukawa marae.

Denise Hapeta, Ngā Hapū o Ōtaki, advised that she intended to provide feedback from Ngā Hapū o Ōtaki to the Iwi Partnership team following Ngā Hapū o Ōtaki's meeting later on that day.

Huriwai Paki, Ngāti Toa Rangatira, advised that he would confirm Ngāti Toa Rangatira's agreement and provide the feedback as soon as possible.

Richard Evans, Ātiawa ki Whakarongotai, noted the request at the previous Te Whakaminenga o Kapiti hui for kaumatua engagement and feedback. Mr Evans advised that this has since been provided to the lwi Partnerships team.

Deputy Mayor Lawrence Kirby acknowledged how exciting it was to be able to celebrate 30 years of the partnership agreement between Kāpiti Coast District Council and the mana whenua of the District. Deputy Mayor Kirby noted the importance to elected members of having confirmation from Council's mana whenua partners (the A.R.T. Confederation of Ātiawa ki Whakarongotai, Ngāti Raukawa, Ngā Hapū o Ōtaki, Ngāti Toa Rangatira) prior to Council's endorsement that each iwi were fully in agreement.

Cr Martin Halliday agreed with Deputy Mayor Lawrence Kirby and advised that he would not be comfortable signing off the partnership agreement prior to the acknowledgement and agreement from iwi partners.

He Heamana Kim Tahiwi acknowledged the sentiments from councillors regarding receiving confirmation from mana whenua prior to endorsing the partnership agreement. He Heamana noted that this showed the level of progress in the relationship between mana whenua and Council. He Heamana committed to providing written confirmation on behalf of Te Whakaminenga o Kapiti, to the Council prior to the hui on Thursday 19 June.

### 7 NGĀ WHAKATAUNGA TIRITI - HE TIROHANGA WHĀNUI NŌ IA IWI | TREATY SETTLEMENTS – OVERVIEW FROM EACH IWI

Denise Hapeta (Ngā Hapū o Ōtaki) advised that there was a good level of interest in the upcoming local elections - particuarly around Māori Ward Representatives, with kōrero amongst the community regarding potential candidates. Ms Hapeta also advised that participating in Crown hearings involves consistent, substantial work and research which has served to limit participants appetite for involvement in other kaupapa.

Mr Huriwai Paki (Ngāti Toa Rangatira) had no further updates at this point in time.

Mr Richard Evans (Ātiawa ki Whakarongotai), spoke regarding the upcoming elections and expressed ab interest in running a wananga following on from one in Ōtaki. Mr Evans provided an update regarding last week's High Court ruling which awarded Ātiawa ki Whakarongotai marine customary title in their rohe, one nautical mile out from hightide mark. Mr Evans advised of the significance of this moment for Ātiawa, acknowledging all the mahi that has gone on during the lengthy process.

#### 8 HE KÖRERO HOU MŌ TE KAUNIHERA | COUNCIL UPDATES

Deputy Mayor Lawrence Kirby advised that Council was looking forward to the continuing conversations in regards to how Council can provide continuing support around the referendum and the Māori Ward process, both now and beyond the election.

Cr Martin Halliday highlighted the importance of candidates standing for the Māori Ward to be supported and have the space to speak to the Māori community and of iwi ability to faciltate some of those spaces.
