#### 6.2 Governance Structure and appointments

Mrs Vyvien Starbuck-Maffey gave a presentation on Council's new governance structure, and opportunities for Maori/liw participation in the new triennium.

That Te Whakaminenga o Kāpiti gives in-principle approval to the appointment of a Māori representative to the Council's Strategy and Operations Committee, and agrees to convene a recruitment panel to manage the initial phase of the reruitment process.

This will also be added to the opportunities for iwi nominations report that willcome back to the meeting next year to confirm.

#### Kapiti Coast Gateway Centre

Morag Taimalietane provided an update around the Kapiti Coast Gateway Centre feasibility study.

The main points that emerged from discussions were

- TRC Tourism have completed a draft report following their discussions with partners and stakeholders involved;
- The project area considered in the draft report was identified through the Maclean Park management plan;
- Ngati Toa and Te Atiawa have spoken with TRC as part of the development of the draft report.
- There is the opportunity for iwi to identify how they would like to partner in this project going forward. A working group was raised as a possible way forward.
- There is the opportunity for designers and carvers to be involved in this
  process/project, this was a potential opportunity identified by Te Atiawa.
- A business case would need to be completed to understand funding and operating models for the Gateway.

#### 6.6 Community led Coastal Adaption

Natasha Tod and Lyndsey Craig spoke about the Community led Coastal Adaption.

Lyndsey provided the following update:

- · a project & communications plan has been put together;
- they are wanting to make sure lwi is at the start of this process and also looking at what ways lwi can be involved through this process;
- they will be running co-design workshops which will be community based and following on from that they will set up community assessment panels, making sure they come out with a shared approach on the best way forward;
- they are looking at holding a community event in February 2020.
