Shona Jaunas spoke about the funding application by Circle of Fifths Production to assist with the costs of hiring the Scout Hall for rehearsals throughout February, and production and equipment storage during production in order to present an outdoor performance of Romeo and Juliet.

Jane Nisbet spoke about SH59 and the connecting road from Paekākāriki to Paraparaumu. She commented that the road starts off wide enough and then narrows, which creates a safety risk. She queried whether the concrete structures in place could be used to extend the road and increase safety, especially for cyclists. She further mentioned that the walking access under SH59 should be maintained. She answered Community Board Members' questions.

Sean McKinley, the Chair, noted the Community Board meeting with Hamish McGillivray, Manager Research and Policy to discuss Vision Paekākāriki and the progress on the work.

The Chair further noted that he has attended Coastal Advisory Panel (CAP) meetings and that members of the panel were in attendance. He welcomed the members (Don Day, Martin Manning and Kelvin Nixon) and invited Don Day to provide a brief overview of the panel's progress to date.

6 HE KÖRERO HOU | UPDATES

6.1 THE TRANSMISSION GULLY PROJECT - SH59 EXTENSION AND STREAM RESTORATION PROCESS

Darren Utting, NZTA Waka Kotahi, provided an update on the Transmission Gully project and the associated SH59 extension work. The project on SH59 is nearing completion and the coast road will be returned to a two-way format shortly.

During stage two, the coast road will need to be closed for a very short period for resurfacing.

Mr Utting noted that most of the works would be completed by the end of summer with remaining work at streams finished by mid-year. Mr Utting answered questions from Community Board Members' and members of the public.

6.2 PAEKĀKĀRIKI SEAWALL UPDATE

The Chair, Sean McKinley clarified the purpose of Community Board meetings for members of the public in attendance. The Chair noted that Community Board meetings are for Council officers to present to the Board and for the Board to ask questions, and advocate on behalf of, the community. The Chair clarified that Board meetings are not an opportunity for the community to ask questions of those presenting and that the public needed to ask questions through their Community Board Members.

Dave Hardy, Manager Project Management Office provided an update on the Paekākāriki Seawall Upgrade project currently underway.

Mr Hardy noted that the project team have undertaken an ecological and herpetology assessment, looked into resource and building consents and have met with the providers Becca and Mills Albert. A detailed design of the seawall and initial designs for the access ways have been drawn up. The replacement will be like for like and any rocks that have been put in front of failing pieces of the wall will be removed. Mr Hardy also summarised the funding of the project and outlined a timeline, noting detailed planning would be finalised by May, consents sought midyear and construction to begin in August.

Mr Hardy answered Community Board Members' questions.

7 PŪRONGO REPORTS

Item 7.1 Election of Community Board Chair and Deputy Chair for the 2022-2025 Triennium was moved to a later point in the agenda.

The Chair, Sean McKinley noted that he was elected Chair of the Paekākāriki Community Board and Kelsey Lee, Deputy Chair, at the start of the triennium with the intention that the role of Chair be transferred to Kelsey Lee during the course of the triennium.
